ORDER

1. The complaint at Diary No.1932024 dated 13.08.2024 has been placed before us with Scrutiny Report dated 23.08.2024.



2. The Scrutiny Report, amongst others, points out following defects:-
 - a. The enclosed copy of Aadhar Card for address proof is illegible.
 - b. Although the complainant has enclosed a few documents with the complaint, he has not provided any particulars/list of the documents relied upon by him. Therefore, it cannot be ascertained whether such documents have been enclosed.
 - c. A signed statement making out the allegations has not been enclosed.

3. The complainant has alleged that the Respondent Public Servant (RPS) who is an employee of the Eastern Railway (Sialdah Division) is also holding the post of Assistant Secretary of a XXXX Trust (name redacted for confidentiality) and thereby has directly involved himself in asking and accepting contributions from the public as well as receiving funds and donations, collecting funds in cash and misappropriating the same for his personal use. His living standard is inconsistent with his income as Railway employee.



4. It is alleged that the public servant has amassed wealth and has acquired multiple flats/properties in the name of his relatives and himself. It is also alleged that the conduct of the named public servant is in violation of the rules and regulations of the 'Railway Servants (Conduct) Rules, 1966'. The public servant has involved himself in the activities of the Trust without permission from the competent authority.

5. We have gone through the allegations made in the complaint and considered the grievance of the complainant. Before considering the complaint on merit, we feel it appropriate to grant an opportunity to the complainant to remove the noted defects as pointed out in the Scrutiny Report within a period of two weeks from the date of communication of this Order.

6. The Registry shall communicate this Order forthwith to the complainant who shall cure the defects within two weeks from the date of receipt of the communication, failing which the complaint shall stand disposed of without reference to the Full Bench.



7. In the event, the complainant cures the defects, the case be notified before the Full Bench in the following week.
