<u>ORDER</u>

1. Registry has put up the complaint before the Full Bench for consideration of the Scrutiny Report and to pass appropriate order.

- 2. Certain defects have been pointed out in the complaint which are as under:
 - (a) The complainant has not enclosed a notarized affidavit with the complaint, only a signed performa of Affidavit generated by the Lokpal Online portal has been uploaded.
 - (b) The complainant has not furnished the name of the public servant(s) complained against (S. No. 1 of Part C of the complaint form).
 - (c) The complainant has not furnished the present designation/ status of the public sevant(s) complained against (S. No. 2 of Part C of the complaint form).
 - (d) The complainant has not furnished the post held by the public servant at the time of commission of alleged offence (S.No.8 of Part C of the complaint form).
 - (e) The complainant has neither provided any particulars/list of the documents relied upon by him, nor has he enclosed any documents with his complaint (S. No. 12 and 14 of Part C of the complaint form).
 - (f) A signed statement of allegations has not been enclosed.
 - (g) The complaint has been received through LokpalOnline Portal, however, the physical copy of the same has not been received for which due date is 30.09.2024. Since the parts of the complaint form are generated by the LokpalOnline Portal, the same are unsigned."
- 3. As there are defects in the complaint which are required to be rectified before the complaint is taken up for consideration, we provide an opportunity to the complainant to rectify the abovementioned defects within fifteen days from the receipt of this order i.e., on or before 15.10.2024, and submit the same to the



office of Lokpal of India within the time limit granted, failing which the complaint shall be treated as disposed of without referring to the Bench.

4. In case the defects are rectified within the time, the matter may be listed in the following week.
