ORDER

1. These complaints were received through the Lokpal Online Portal.
The complainant has made two identical complaints dated



25.10.2024 and 26.10.2024 which were diarized as Diary No.2592024 and Diary No.2612024.

2. These complaints have been placed before the Full Bench for consideration of the Scrutiny Report and to pass appropriate order.
3. Perused the Scrutiny Report.
4. The Scrutiny Report has pointed out the following defects:-
 - (i) The complainant has not furnished his name in the Column (S.No.2 of Part A of the complaint form).
 - (ii) The complainant has not enclosed his identity/residence proof with the complaint form (S.No.6 of Part A of the complaint form)
 - (iii) The complainant has not furnished his permanent/correspondence address (S.Nos. 7&8 of Part A of the complaint form).
 - (iv) The complainant has not enclosed a notarized affidavit with the complaint; only a proforma of affidavit generated by the LokpalOnline portal has been uploaded.



- (v) The complainant has not furnished the post held by the public servant at the time of the commission of the alleged offence (S.No.8 of Part C of the complaint form).
- (vi) In S.No.13 of the complaint form, the complainant has referenced an RTI application filed on 02.09.2024 vide Registration No.MCODH/R%/2024/63225 and Complaint No.MINHA/E/2024/024969; however, neither document has been enclosed.
- (vii) A signed statement of allegations has not been enclosed.
- (viii) These complaints have been received through LokpalOnline portal, however, the physical copy of the same has not been received. Since the parts of the complaint form are generated by the Lokpal Online Portal, the same are unsigned.

5. The Full Bench has noted that many defects in the complaints are required to be cured. Hence, we provide an opportunity to the complainant to cure the defects as pointed out by the Registry of the Lokpal of India. The Registry of the Lokpal of India shall issue notice to the complainant providing him two weeks from the receipt of the aforesaid notice to cure the defects, failing which the



complaints shall stand disposed of without further reference to the Bench.

6. In case the defects are removed by the complainant, the Registry shall list the case immediately thereafter in the following week before the Full Bench.
