**ORDER**

1. The complaint is placed before the Full Bench for consideration of the Scrutiny Report and to pass appropriate order.



2. The complaint is against the Chief Executive Officer (CEO) of the Jodhpur Municipal Corporation North, Rajasthan. The complainant has not provided sufficient information relating to the allegation, making it difficult to ascertain the nature of the allegation.
  
3. The Registry of Lokpal has pointed out the following defects in its Scrutiny Report dated 29.10.2024:
  - (i) The complainant has not enclosed an affidavit on non-judicial stamp paper with the complaint.
  
  - (ii) The complainant has not given any particulars/list of documents relied upon. (S. No. 12 of Part C of the complaint form)
  
  - (iii) The complainant has enclosed some copies, but it cannot be ascertained, as there is no list attached with the complaint. (S. No. 14 of Part C of the complaint form).
  
4. The complainant is granted two weeks' time to cure the aforesaid defects.
  
5. The complainant be informed, accordingly.
  
6. In case, the defects are not cured by the complainant within the time granted, in terms of this order, the Registry may treat this order as a



conditional order, disposing of the complaint being defective without reference to the Bench.

7. If the defects are cured in time, the case be listed in the following week.
