## ORDER

1. The Scrutiny Branch has placed the complaint dated 26.10.2024 at the diary stage, for consideration, before the Full Bench. We have perused the file.
2. The complaint has been made through Lokpal Online Portal and the Registry has not received the signed physical copy of the complaint. The Scrutiny Branch has listed the following defects in the complaint. The complainant is granted time to cure the following defects:
  - i) The complainant has not enclosed a notarised affidavit with the complaint; only a blank proforma of affidavit generated by the LokpalOnline portal has been uploaded.
  - ii) The complainant has not furnished the name and present designation of the public servant complained against (S. Nos. 1 & 2 of Part C of the complaint form).



- iii) The complainant has not furnished the post held by the public servant at the time of the commission of the alleged offence (S.No.8 Part C of the complaint form).
- iv) The complainant has not provided any particulars/ list of the documents relied upon by her. Therefore, it cannot be ascertained whether such documents have been enclosed (S.No.12 and 14 of part C of the complaint form).
- v) A signed statement of allegations has not been enclosed.
- vi) The complaint has been received through Online Portal, however, the physical copy of the same has not been received (Due date 10.11.2024). Since the parts of the complaint form are generated by the Lokpal Online Portal, the same are unsigned.

3. Under these circumstances, we deem it appropriate to grant two weeks' time to rectify the defects, pointed out by the Registry. That shall be done before 03.12.2024, failing which the complaint shall be

deemed to have been disposed of without any further reference to Full Bench.

4. If the defects are cured in time, the complaint be listed in the following week.
5. The registry is directed to do the needful.
