<u>ORDER</u>

- 1. The Registry has placed the complaint for the consideration of the Full Bench.

- (iv) The complainant has mentioned "No" in this column with reference to the post held by the public servant at the time of commission of alleged offence. (SI. No. 8 of Part C of the complaint form).
- (v) The complainant has not given any particulars/ list of documents relied upon, nor any such copies are enclosed. (Sl. No. 12 & 14 of Part C of the complaint form)
- (vi) A signed statement of allegations addressed to the Lokpal of India has not been enclosed.
- (vii) The complainant has been received through Lokapl Online portal; however, the physical copy of the same has not been received (Due date-23.11.2024). Since the parts of the complaint form are generated by the Lokpal Online portal the same are unsigned.
- 3. We are of the considered opinion that the complainant may be asked to remove the above defects within a period of two weeks from the date of issue of this order. Failing which, the matter shall stand disposed of without further reference to the Bench.

- 4. The Registry is directed to send this order also online to the complainant for the removal of the defects.
- In case the defects are cured within given period, the matter may be listed in the following week.
