ORDER

1. The Registry has placed the complaint for the consideration of the Full Bench.
2. The Scrutiny has mentioned various defects in the complaint which are as under:

“(i) An address proof has not been enclosed with the complaint. The complainant has provided only the



front side of the Aadhaar Card which only contains details of the identity.

- (ii) The complainant has not enclosed an affidavit on non-judicial stamp paper with the complaint.
- (iii) The complainant has not mentioned the name of the public servant(s) against whom complaint is being made (Sl. No.1 of Part C of the complaint form).
- (iv) The complainant has mentioned "No" in this column with reference to the post held by the public servant at the time of commission of alleged offence. (Sl. No. 8 of Part C of the complaint form).
- (v) The complainant has not given any particulars/ list of documents relied upon, nor any such copies are enclosed. (Sl. No. 12 & 14 of Part C of the complaint form)
- (vi) A signed statement of allegations addressed to the Lokpal of India has not been enclosed.
- (vii) The complainant has been received through Lokpal Online portal; however, the physical copy of the same has not been received (Due date- 23.11.2024). Since the parts of the complaint form are generated by the Lokpal Online portal the same are unsigned.

3. We are of the considered opinion that the complainant may be asked to remove the above defects within a period of two weeks from the date of issue of this order. Failing which, the matter shall stand disposed of without further reference to the Bench.



4. The Registry is directed to send this order also online to the complainant for the removal of the defects.
5. In case the defects are cured within given period, the matter may be listed in the following week.
