ORDER

1. The complaint has been placed before the Full Bench along with Scrutiny Report dated 20.10.2024.
2. As per the Scrutiny Report, following defects have been observed in the complaint:-

(a) *The complainant has not enclosed a duly signed and notarized affidavit on a non-judicial stamp paper (S.No. 13 of Part A of the complaint form).*

(b) The complainant has not enclosed a signed statement of allegations with the complaint.

(c) The complaint has been received through Lokpal Online portal, however, the physical copy of the same has not been received (Due date 14.12.2024). Since the parts of the complaint form are generated by the Lokpal Online portal the same are unsigned.

3. The allegations, as derived from the documents attached with the complaint, appears to be against the Professor and Coordinator of BS degree, IIT Madras. It appears that the complainant has experienced racial abuse and miscommunication within students' group, namely 'Diplomacia' at IIT Madras. Allegations do not indicate any offence of corruption as per the provisions of Prevention of Corruption Act, 1988. However, before considering the complaint on merit, we would like to give an opportunity to the complainant to rectify all the defects and also disclose an act which is amenable to the jurisdiction of the Lokpal of India.
4. We, therefore, provide two weeks' time to the complainant to remove the defects as noted above. In case the complainant fails to rectify the defects within the time provided, the complaint shall be treated as disposed of without any reference to the Bench.
5. The Registry is directed to communicate this Order forthwith to the complainant on his E-mail ID, if any, in addition to by regular mode.



6. List on 03.01.2025 or, in case the defects are cured earlier, the Registry may post the matter immediately thereafter in the following week.
