ORDER


1. The complaint dated 19.12.2024 is against the Professor and Coordinator of B.S. Degree, IIT Madras.

2. The complainant had earlier filed one more complaint vide Dy.



No.2932024. The complaint was against the Coordinator of B.S. Degree, IIT Madras wherein it had been alleged that the complainant experienced racial abuse and exclusion within a students' group namely 'Diplomacia' at IIT Madras. The said complaint was earlier placed before the Full Bench and vide a conditional order dated 13.12.2024 granted two (02) weeks' time to the complainant to rectify the defects in his complaint as stated in the said order. The order was communicated to the complainant vide letter dated 18.12.2024 by e-mail and by post.

3. Now, the complainant has filed this instant fresh complaint dated 19.12.2024 (Dy.No. 3092024), made the same allegations of experiencing racial abuse and exclusion with a students' group at IIT Madras against 10 public servants (including one public servant from a previous complaint i.e. Dy. No.2932024). The physical communication from the complainant has been received on 31.12.2024 vide which the complainant has submitted a few additional/ supporting documents. However, the defects mentioned in the Scrutiny Report dated 19.12.2024 have not been rectified.

4. No explanation is offered in this complaint as to why he failed to cure the defects in the previous complaint, which stood disposed of for non-removal of the defects.
5. Be that as it may. Since the complainant has made allegations against ten other persons (other than the originally named one public servant), we may examine the complaint provided the complainant takes steps to remove the defects pointed out in the Scrutiny Report dated 19.12.2024. The same reads thus:
 - a. *"The complainant has not enclosed a duly signed and notarized affidavit on a non-judicial stamp paper.*
 - b. *The complainant has enclosed the statement of allegations with the complaint, however, it is unsigned.*
 - c. *The complaint has been received through Online Portal; however, the physical copy of the same has not been received (Due date 03.01.2025). Since the parts of the complaint form are generated by the Lokpal Online Portal, the same are unsigned.*
6. The complainant shall remove the defects within two weeks from today, failing which the complaint shall be treated as disposed of being defective without further reference to the Bench.
7. The complainant be informed, accordingly.



8. If defects are cured in time, the complaint be listed in the following week.
