1. Perused the record.

- 2. Following defects are observed by the Registry, viz.,
 - "(a) The complainant has not enclosed any letter addressed to the Lokpal of India.
 - (b) The complainant has not provided the particulars/list of documents relied upon by the complainant.
 - (c) Since, the complainant has not given any particular list of the documents in S.No.12 of Part C of the complaint form, it cannot be ascertained whether such documents have enclosed in the Column 14 of Part C.
 - (d) The physical copy of the complaint has not been received yet and thus the complaint form is unsigned and only scanned copy of the affidavit has been uploaded. "
- 3. The complaint is directed against Chairperson and Executive Engineer, Nagar Palika Parishad, Bisalpur, Pilibhit, Uttar Pradesh. Against the Chairperson the allegations are that her husband sits on the chair and takes all decisions. Whereas, against the Executive Engineer the allegations are that, he has refused to carry out the order of demolition of a dilapidated house which belongs to the complainant.
- 4. Evidently, the complaint is against Chairperson and the Executive Engineer, Nagar Palika Parishad, Bisalpur, Pilibhit which is a creature of



state law, i.e. the Uttar Pradesh Municipalities Act, 1961 and not a Central Act.

- 5. In view whereof the persons against whom the complaint is lodged are not amenable to the jurisdiction of Lokpal under Section 14 of the Lokpal and Lokayuktas Act, 2013.
- 6. Therefore while ignoring the defect pointed out by the Registry, the complaint is finally disposed of being not tenable, with the liberty to the complainant to avail remedy before appropriate forum under law.
