ORDER

1. Pursuant to our order dated 08.11.2024, the named RPS has filed her response by way of affidavit sworn on 07.12.2024 in time, raising preliminary issues as well as giving explanation allegation-wise. It is appropriate and in the interest of justice that the complainants are



provided copy of the affidavit and documents filed by the RPS by way of response to the respective complaints and the supplementary affidavits.

2. Further, we deem it appropriate that the RPS as well as the complainants can be given opportunity of oral hearing to clarify their positions taken in the complaints or the affidavit, as the case may be.
3. Accordingly, we direct the Registry to issue Notice to the RPS as well as the complainant(s) to avail of the opportunity of oral hearing on 28.01.2025 at 11.30 a.m.
4. It will be open to the RPS as well as the complainant to authorize advocate to espouse their cause, if they so desire at the time of oral hearing.
5. The Registry is directed to forward copy of the affidavit of the RPS and its accompaniments to the complainants in respective complainants. The complainants, however, shall ensure that the confidentiality of the process and the contents of the affidavit is maintained as per Section 20(9) of the Lokpal and Lokayuktas Act, 2013 (for short, the Act of 2013) read with Rule 4(a) and 4(b) of the Lokpal (Complaint) Rules, 2020, without any exception.



6. RPS and complainants, if wish to rely on any reported decisions must file compilation(s) of such decisions duly paginated, well in advance and not later than 18.01.2025.
7. Since the previous orders have been placed in public domain, we deem it appropriate to place even this order in public domain for the same reason.
