## **ORDER**

- The complaint at Diary No.2092024 dated 05.09.2024 along with Scrutiny Report dated 13.09.2024 has been placed before the Full Bench of Lokpal for consideration.
- 2. The Scrutiny Report has pointed out the following defects:-



- a. The complainant has not attached any address proof with the complaint.
- b. The complainant has mentioned SDPO's voice recording and ACP's voice recording, however, the voice recordings are not physically attached with the complaint.

3.

- The complaint has been filed against certain judicial officers viz. one Judicial Magistrate and three Addl. District Judges posted at Barasat and Barrackpore, West Bengal. It is alleged by the complainant that he is caught in a 15-year old legal battle and the named public servants have involved themselves in systemic judicial corruption by tampering court orders, forging documents, misuse of law and passing biased orders. He claims that he is being subjected to 'judicial terrorism' and fears for his life as his 15 year legal battle has resulted in threats, wrongful ex-parte orders, fraudulent appearances by multiple women claiming to be his wife and forged documents. He accuses the Judicial Officers of conspiring against him resulting in unlawful freezing of his salary for three years and numerous ex-parte orders. Further, the complainant asserts that he has been assaulted by advocates, despite police protection and accuses them of involvement in a large corruption scandal.
- 4. We have gone through the allegations set out in the complaint and given our thoughtful consideration. The named public servants are the State Govt. employees and they are in no manner associated or

connected with the affairs of the Union of India in discharge of their work and duties. The present complaint is not amenable to the jurisdiction of the Lokpal as specified in Section 14 of the Lokpal & Lokayuktas Act, 2013 (the Act).

- No fruitful purpose would be served in granting time to the complaint to remove the defects as the present complaint is not maintainable under the Act.
- 6. The complaint stands disposed of with liberty to the complainant to approach the appropriate authority as may be permissible in law.
