ORDER

1. The matter was earlier placed before the Full Bench and vide a conditional order dated 14.11.2024, the Full Bench granted two



weeks time to the complainant to cure the defects noted in the Scrutiny Report. Now the complainant has rectified all the defects.

2. The complaint is against the Chief Executive Officer (CEO) of the Jodhpur Municipal Corporation, North Rajasthan. The complainant has alleged that she had filed multiple complaints with the Jodhpur Municipal Corporation North in order to remove illegal encroachments made by the neighbours in front of her house, however, no action has been taken. Therefore, she escalated the complaint to the Rajasthan Lokayukta. Further, the Corporation marked and partially removed encroachments but targeted only the area in front of the complainant's house, leaving the encroachment in the neighbourhood intact. The complainant also alleges bias and incomplete action by the Corporation as, the team abruptly halted the work, citing external calls, and later claimed that no further action would be taken due to holidays. The complainant has requested for a thorough investigation and removal of all the remaining encroachments.

3. The Full Bench perused the complaint. The public servant against whom the complaint is made is serving in connection with the affairs

of the State Government of Rajasthan. As such, the stated public servant is not amenable to the jurisdiction of the Lokpal as per Section 14 of the Lokpal and Lokayuktas Act, 2013. Moreover, the matter is under active consideration of Lokayukta Rajasthan.

4. The complainant may draw the attention of appropriate authority, if there is any further grievance.
5. Accordingly, the complaint stands disposed of.
