## <u>ORDER</u>

1. In the complaint (Diary No. 2972024), the Full Bench vide order dated 31.1.2025 had granted two weeks further time to the complainant to remove the defects. However, as per the Scrutiny Report dated 13.02.2025 of the Registry, no communication has been received from the complainant.

- 2. Earlier, the Full Gourt vide order dated 20.12.2024 had passed a conditional order granting two weeks' time to the complainant to remove the defects. Thereafter, vide order dated 31.1.2025, after noting that the complainant has partially cured the defects, had granted two weeks further time to do the needful.
- The complainant has not cured the defect in spite of time granted.
  However, we proceed to decide the case on merits.
- 4. The complaint has been filed against the Executive Engineer, CPWD Division, Kannur, Kerala, Executive Engineer (E), Calicut Electric Division, CPWD, Kendriya Bhavan, Kallai, Calicut, Superintending Engineer, Calicut, CPWD, MS Baburaj Road, P.O. Kallai, Kozhikode and M/s Tati Construction Pvt. Ltd., Kondotty, Malappuram Kerala.
- 5. The facts of the case, as set out in the complaint by the complainant, it is about the non-payment of the dues for the work done by the complainant pursuant to the agreements executed between the complainant and the Respondent No. 4.
- It appears that some work was allotted by the Respondent Nos.1, 2 and 3 to the Respondent No. 4 which is a contracting agency,

for getting some electrical works to be executed in the Department of Zoology at Mananthavadi Campus, Kannur University, Kerala. The Respondent No. 4 entered into two agreements dated 18.07.2019 and 21.03.2020 with the complainant to execute the allotted work on his behalf.

- 7. The Respondent Nos. 1, 2 and 3, vide letter dated 13.09.2024 and 18.10.2024 informed the complainant that the entire payment of electrical final bills against the said works have already been paid to the main agency M/s Tati Construction Pvt. Ltd (Respondent No. 4) on 28.08.2024.
- 8. From the above facts, it is clear that the dispute, if any exists, is between the complainant and Respondent No. 4 which is not a public authority.
- 9. Moreover, the complainant has not made any specific allegations of corruption against the Respondent Nos. 1, 2 or 3.
- 10. In the given facts and circumstances, we do not find it to be appropriate case to intervene.



11. The complaint is disposed of with liberty to the complainant to avail appropriate legal remedy for redressal of his grievance, as may be advised.
