The complaint is made against the Sub Registrar,
Thiruvananthapuram (Principal), Survey Superintendent, ReSurvey Superintendent Office Karamana CSO, Vazhuthacadu,
Deputy Collector, Kudappanakunnu, Thiruvananthapuram,
Survey Superintendent Re-Survey Superintendent Office,
Kazhakuttam, Assistant Director, Assistant Director Office



(Mapping), Thiruvananthapuram (Ambalamukku), Village Officers of Pettah, Vanchiyoor and Kadakampally Village and Tahasildar, Thiruvananthapuram, Kerala.

- 2. The complainant has alleged systemic fraud in revenue records and illegal land transactions in District Thiruvananthapuram, Kerala, involving multiple government officials. A fraudulent document with manipulated details facilitated illegal land sales including one in 2018. A re-survey conducted during the year 2021, due to COVID-19 lockdown, erased crucial ownership data, involvement of the Sub Registrar in concealing past frauds and forged registrations, Deputy Collector for concealment of land acquisition data, Re-survey Officer for manipulating survey records and Village & Taluk Officers for showing discrepancies in tax data, land records and unauthorized land transactions.
- 3. The perusal of the Statement of Allegations clearly indicates that the public servants are the State Government officials and they are engaged with the affairs of the State Government. None of the allegations relate to the involvement of the public servants with the affairs of the Union of India, and, as such are not amenable to the jurisdiction of the Lokpal of India under Section 14 of the Lokpal and Lokayuktas Act, 2013.

4. Consequently, the complaint is disposed of. The complainant will, however, be at liberty to approach the appropriate authority for redressal of his grievance.
